

# Inepro WebLoader Terms of Use

I agree to the following conditions that apply to the use of the Inepro WebLoader application (hereinafter referred to as the Application):

1. I will only use the system for its intended purpose: to top up my personal credit (account) to be used within the organisation to which I belong for electronic payment of purchases of products such as photocopies, printing, food and non-food products.
2. I will not use the Application for unintended purposes; I will not attempt to hack or overload the Application, I will not attempt in any way to steal, delete or alter information of any kind belonging to other users, I will not attempt to steal, delete or alter e-mail addresses or other personal data belonging to users of the Application. If I do commit any of the aforementioned acts, I will take full responsibility for my actions and for all consequences and I am accountable for all direct, indirect and consequential damages resulting from my actions; I indemnify the supplier of the Application, in advance, for all direct, indirect and consequential damages resulting from my actions.
3. I am always responsible for the transactions I make using the Application. I indemnify the supplier of the Application, in every country, for all responsibility for the consequences resulting from my use of the Application.
4. I am aware of the fact that the internet is a public space and that the supplier of the Application has taken measures, to the best of its ability, to secure the Application and that these measures are active. I make a conscious decision to use this Application and indemnify the supplier of the Application for all consequences resulting from my use of the Application.
5. I agree to my password and other personal data requested by the Application being saved. I fully accept the risk that my password and personal data may become known to a third party and may be subsequently published online or otherwise made available. I declare that I have familiarised myself with the Application's security measures provided by the supplier of the Application and decide to use the Application of my own free will. I indemnify the supplier of the Application, in advance, for any breaches of my personal data saved in the Application, regardless of which party is responsible for the violation.
6. The supplier of the Application will not transfer, sell, publish, release or use data that has been saved in the Application in any way other than is intended for use within the Application.
7. I indemnify, in advance, the supplier of the Application for all negative consequences and all direct, indirect and consequential damages, resulting from every disturbance and malfunction of the Application. I cannot and will not assert any rights to the availability of the Application as a whole or the availability of related payment facilities. The availability or unavailability of any

payment facilities within the organisation to which I belong or which manages my account, does not give me the right to reclaim amounts or parts of amounts of completed transactions.

8. I declare that I am aware that the supplier of the Application merely provides a portal and does not manage the data that has been saved in the Application. Any questions I have about the saved data or management thereof, such as managing credit and requesting refunds, I will ask at the service desk of the organisation to which I belong or which manages my account.
9. I declare that I am aware that a completed transaction made using the Application is definitive; once executed, the money has been transferred from my debit or credit card and the calculated equivalent value of the sum has been added to the account of the person whose password was used when completing the transaction through the Application. I declare that I am aware that the supplier of the Application will not accept requests for refunds of transaction amounts or parts thereof. I will not submit requests for refunds to the supplier of the Application but I can submit requests at the service desk of the organisation to which I belong or which manages my account.
10. I declare that I am aware that there are possible fees associated with making transactions using the Application; I will pay these fees.
11. I declare that I am aware that the supplier of the Application is at liberty to change the amounts it charges without any prior notification; I declare that I agree for these costs to be revealed to me at the actual moment I make a transaction using the Application.
12. I declare that I am aware that the supplier of the Application is at liberty to change the appearance of the Application without any prior notification; I declare that I agree for the altered appearance to be revealed to me at the actual moment I make a transaction using the application.
13. I declare that I am aware that in the event of any malfunction of the Application, I will report this malfunction to the service desk of the organisation to which I belong or which manages my account, providing a description of the malfunction including my data and email address and possibly my password. The organisation will first attempt to solve the malfunction and, if necessary, the organisation will contact the supplier of the Application to allow them solve the malfunction.
14. I declare that I am aware that the supplier of the Application offers the highest degree of availability of the Application to the best of its ability. I accept the risk that the Application may not available for use at certain times and I indemnify, in advance, the supplier of the Application for all possible consequences, including but not limited to, all direct, indirect and consequential damages resulting from the unavailability of the Application.

15. I am aware that this agreement is subject to Dutch law and I hereby accept this.
16. I am aware that the General Conditions of the supplier of the Application apply and I hereby accept them. The General Conditions of the supplier of the Application are available on the website of the supplier of the Application.
